Hazard Statement:

Causes skin irritation. May cause an allergic skin reaction. Harmful to aquatic life. May cause respiratory irritation.

Precautionary Statements (Prevention):

Wear protective gloves. Use only outdoors or in a well-ventilated area. Do not breathe dust/gas/mist/vapours. Avoid release to the environment. Contaminated work clothing should not be allowed out of the workplace. Wash with plenty of water and soap thoroughly after handling.

4. First-Aid Measures

General advice:

First aid personnel should pay attention to their own safety. Remove contaminated clothing.

If inhaled:

If difficulties occur after vapour/aerosol has been inhaled, remove to fresh air and seek medical attention.

On skin contact:

After contact with skin, wash immediately with plenty of water and soap. Under no circumstances should organic solvent be used. If irritation develops, seek medical attention.

On contact with eyes:

Wash affected eyes for at least 15 minutes under running water with eyelids held open, consult an eye specialist.

On ingestion:

Rinse mouth immediately and then drink plenty of water, seek medical attention. Do not induce vomiting unless told to by a poison control center or doctor.

Note to physician:

Treatment: Treat according to symptoms (decontamination, vital functions), no known specific antidote.

5. Fire-Fighting Measures

Suitable extinguishing media:

6. Accidental Release Measures

Personal precautions:

Use personal protective clothing. Do not breathe vapour/aerosol/spray mists. Handle in accordance with good building materials hygiene and safety practice.

Methods for cleaning up or taking up:

7. Handling and Storage

Handling

Avoid aerosol formation. Avoid inhalation of mists/vapours. Avoid skin contact. No special measures necessary provided product is used correctly.

Protection against fire and explosion:

Storage

Suitable materials for containers: High density polyethylene (HDPE)

Further information on storage conditions: Keep only in the original container in a cool, well-ventilated place. Protect from direct sunlight. Store protected against freezing.

Components with occupational exposure limits

Personal protective equipment

Respiratory protection:

Wear respiratory protection if ventilation is inadequate. Combination filter for gases/vapours of organic, inorganic, acid inorganic and alkaline compounds (e.g. EN 14387 Type ABEK).

Hand protection:

Suitable chemical resistant safety gloves (EN 374) also with prolonged, direct contact (Recommended: Protective index 6, corresponding > 480 minutes of permeation time according to EN 374): E.g. nitrile rubber (0.4 mm), chloroprene rubber (0.5 mm), butyl rubber (0.7 mm) etc.

Manufacturer's directions for use should be observed because of great diversity of types.

Eye protection:

Safety glasses with side-shields (frame goggles) (e.g. EN 166)

Body protection:

Body protection must be chosen depending on activity and possible exposure, e.g. apron, protecting boots, chemical-protection suit (according to EN 14605 in case of splashes or EN ISO 13982 in case of dust).
