Our solution

These challenges were overcome by combining both the Master Builders Solutions Type A and type B systems, which together, creates two forms of watertight protection and provides a Grade 3 specification.

MasterLife WP 754 membrane provided a barrier system along with our MasterLife WP 799 being added to the structural reinforced concrete to provide the second layer of waterproofing protection.

At all construction joints (the weak point of any structure) the use of our MasterLife WP 910/912 hydroswelling waterbar and mastic system was used to create a watertight seal.
