

SRT Mesh (Stucco Reinforcing Treatment Mesh)

Glass fiber mesh for use with Stucco

DESCRIPTION

SRT Mesh is a woven fiber glass mesh with high mechanical strength and dimensional stability.

PACKAGING

Sold by the pallet. 33 rolls per pallet. 39.4" x 164' (100 cm x 50 m)

White, printed "Not for use with EIFS"

USES

For use with Wall Systems Stucco, and Stucco Resurfacing Systems for improved crack resistance.

ADVANTAGES

Alkali resistant, compatible with all Base Coats; high tensile strength and flexibility for long-term durability.

Increased flexural & tensile strength at ultimate load compared to stucco without SRT Mesh/ Base Coat.

APPLICATION

Note: Allow stucco to cure a minimum of 6 days prior to application of Base Coat / SRT Mesh.

1. All surfaces to receive Base Coat and SRT Mesh must be clean, dry and free of contaminants.
2. Apply mixed Base Coat to entire surface of stucco with a stainless steel trowel.
3. Immediately place SRT Mesh against wet Base Coat and embed SRT Mesh into the Base Coat by troweling from center to the edges.
4. Lap SRT Mesh 64mm (2 ½") minimum at edges.
5. Ensure SRT Mesh is continuous, void of wrinkles and embedded in Base Coat so that no SRT Mesh is visible.
6. If required, apply a second layer of Base Coat to achieve total nominal Base Coat / SRT Mesh thickness of 1.6 mm (1/16").
7. Allow Base Coat with embedded SRT Mesh to dry hard (normally 8 to 10 hours) prior to finish coat application.

LIMITATIONS

1. For Stucco Wall Systems only. Not for use in Exterior Insulation and Finish Systems (EIFS) or Cement Board Stucco Systems.
2. Store SRT Mesh in a cool, dry place protected from exposure to moisture.
3. See specifications and details for complete information on installation of Wall Systems.
4. Apply in temperatures of 4 °C (40 °F) and higher.
5. Protect SRT Mesh during transportation and installation to avoid physical damage.
