MasterFinish RL 418 is a low viscosity form release agent, composed more than 85% on renewable raw materials, and suitable for all methods of compaction and concrete consistencies. The product can be used in precast concrete element and ready-mix construction and civil engineering. Its exceptional penetrating properties make it suitable for mixer maintenance as well.

Features and benefits

MasterFinish RL 418 is a highly reactive, chemically/ physically acting release agent based on renewable raw materials. Its low

viscosity provides good workability and high coverage. Special-purpose additives ensure easy formwork release and good corrosion protection while keeping the formwork clean.

MasterFinish RL 418 facilitates the production of clean fairfaced concrete surfaces without any stains or

blowholes. MasterFinish RL 418 is biodegradable > 60% at 28 days following the EN ISO 9408-OCDE 301 B, is not labelled and can be used with foamed plastics such as Styropor or Neopor.

Coverage

Depending on the type of formwork, we advise 1 liter for 40 $\ensuremath{\mathsf{m}}^2.$

Packaging

MasterFinish RL 418 is available in 20L cans, 200L drums and 1.000L tanks.

Storage

MasterFinish RL 418 can be stored in its original, unopened container for a minimum of 12 months; keep away from frost and direct sunlight. Observe the ordinance on plants for storing, bottling and handling water-polluting substances.

Application

MasterFinish RL 418 is a ready-to-use product and is applied onto the pre-cleaned, dry formwork undiluted, evenly and thinly, using a high-pressure sprayer, a rotary applicator or a mounted spray-bar system. Avoid or re-move excess quantities of the release agent. When using vibration compaction equipment, make sure to observe the manufacturer's specifications of vibration duration and vibration frequency. Avoid any additional vibration. Avoid prolonged contact with zinc-coated metal parts as this may result in reactions with some of the ingredients. Never mix
